## 2.0 USES

The western red cedar shakes and shingles are wood roof covering materials for use where the codes permit nonclassified (IBC and IRC) or nonrated (UBC) roof covering.

## 3.0 DESCRIPTION

The western red cedar shakes (nonpreservative-treated) are manufactured in accordance with the grading rules specified in 2015, 2012 and 2009 IBC Section 1507.9.6 and 2006 IBC Section 1507.9.5, IRC Section R905.8.5 and UBC Standard 15-3.

The western red cedar shingles (nonpreservative-treated) are manufactured in accordance with the grading rules specified in 2015, 2012 and 2009 IBC Section 1507.8.5 and 2006 IBC Section 1507.8.4, IRC Section R905.7.4) and UBC Standard 15-4.

## 4.0 INSTALLATION

The western red cedar shakes must be installed in accordance with IBC Section 1507.9, IRC Section R905.8 or UBC Table 15-B-2, as applicable.

The western red cedar shingles must be installed in accordance with IBC Section 1507.8, IRC Section R905.7 or UBC Table 15-B-2, as applicable.

## 5.0 CONDITIONS OF USE:

The western red cedar shakes and shingles described in this report comply with, or are suitable alternatives to what is specified in, those codes listed in Section 1.0 of this report, subject to the following conditions:

- 5.1 Products must be identified as shown in [Figure 1](#) of this report.
- 5.2 Products are manufactured by Premium Cedar Products Ltd. and are inspected by Intertek Testing Services NA, Inc. (AA-647).
- 5.3 The products must be installed as noted in Section 4.0.

Each pallet must have a pallet release tag showing the mill name (Premium Cedar Products, Ltd.), the mill address, the packing date, the product type, the evaluation report number (ESR-2573) and the dated signature of the responsible person releasing the material.
